Information Regarding Guthrie Youth Football Fall 2012 Season

- Governed by Central Oklahoma Little League Football, Inc of "COLLF"
- Participates in the Deep Fork Valley Football Assocation (deepforkvalleyfootball.com)
- Teams for 2nd, 3rd, 4th, 5th, & 6th grades (1st graders are welcome to participate with 2nd)
- There will be a weigh-in and orientation by grade towards the end of July
- Practices start around first of August, then 8-10 week season, playoffs first of November
- Registration Fee provides a jersey and participants liability insurance
- Anyone who has contact with your child will have undergone an OSBI background check
- · Home games are played at the GHS football practice field east of the high school

In 2011, we entered one team per grade in the Deep Fork Valley League. It is the desire of the COLLF Board of Directors to enter TWO teams per grade into the DFVL in 2012. Our mission is to promote participation in the sport of football in Guthrie in an attempt to increase the number of experienced players as they enter junior high & high school. We are in the midst of the greatest era of high school football in our Community's history, and our way of contributing to that success is to foster a competitive and quality little league football environment.

In January, the COLLF Board of Directors made a request to the Deep Fork Valley League that Guthrie be allowed to enter TWO teams per grade into their association for 2012. That request was granted providing that we are able to enter two teams in EACH grade level. If we don't have enough sign-ups in any one grade, 2nd thru 6th, then we will be forced to scale back to just the one team per grade. The Deep Fork Valley League has given Guthrie a firm deadline of July 1st, 2012 to show ample registration to support two squads. Therefore, we are sending out these registration packets much earlier than in the past. Our minimum registration is 32 per grade in order to have (2) 16 player teams. IF ANY ONE GRADE FAILS TO HAVE 32 PLAYERS SIGN UP, WE WILL BE FORCED TO ONLY ENTER ONE TEAM PER GRADE.

THEREFORE IT IS VERY IMPORTANT TO GET THIS REGISTRATION RETURNED OR AT THE VERY LEAST MAKE YOUR CHILD'S INTENTION TO PARTICPATE MADE KNOWN TO LEAGUE OFFICIALS.
